

## INTEGRIS SOUTHWEST MEDICAL CENTER

### Staff Category Descriptions:

**Provisional Medical Staff:** Applicants to the Active Staff, Consulting Staff and Courtesy Staff who are appointed as Medical Staff Appointees shall initially be appointed to the Provisional Staff for a minimum period of one (1) year.

**Active Medical Staff:** The Active Medical Staff shall consist of physicians and dentists who regularly admit, attend, or are regularly involved in the treatment of patients in INTEGRIS Southwest Medical Center, who are located closely enough to the hospital to provide continuous care to their patients, and who assume all the functions and responsibilities of Membership on the Active Medical Staff. They shall attend such patients as are admitted to their service and shall accept the responsibility of attending physician as called upon to do so pursuant to the emergency patient care schedule. Active Staff Appointees shall be required to be involved directly or indirectly in the care of more than twenty-five (25) Medical Center patients per year, either through admission of such patients to the Medical Center or consultations with attending physicians of Medical Center patients.

**Senior Active Staff:** Upon attaining the age of sixty-five (65), each Active Staff Appointee shall be assigned to the Senior Active Staff. Senior Active Staff Appointees shall not be required to participate in any emergency patient care call schedule.

**Courtesy Medical Staff:** The Courtesy Medical Staff shall consist of qualified physicians and dentists who do not regularly admit, attend, or are not regularly involved in the treatment of patients in INTEGRIS Southwest Medical Center. Courtesy Staff Appointees may provide coverage for Appointees of the Active, Provisional, Courtesy, or Consulting Staff.

**Consulting Medical Staff:** The Consulting Medical Staff shall be limited to recognized specialists who are appointed for the specific purpose of providing consultation to Active, Provisional, and Courtesy Medical Staff Appointees.

**Associate Medical Staff:** The Associate Staff shall consist of physicians and dentists licensed in the State of Oklahoma who are in administrative positions and/or who do not have an Active practice at INTEGRIS Southwest Medical Center but who are affiliated with INTEGRIS Health through employment, contract, referral relationships, or use of an INTEGRIS Health facility. The Associate Staff shall be entitled to library privileges, notification of and participation in Staff functions and educational events

sponsored by INTEGRIS Southwest Medical Center and receipt of INTEGRIS Health publications. Associate Staff Appointees shall not be entitled to admit patients to INTEGRIS Southwest Medical Center.

**Telemedicine/Teleradiology:** The Telemedicine/Teleradiology staff shall consist of physicians of demonstrated competence qualified for staff appointment who are not eligible for appointment to the Active Staff because they intend to provide only consultation through telemedicine or teleradiology. The Telemedicine/Teleradiology staff shall have no staff committee responsibilities, may not vote, and may not hold office.
